During miking campaign, relevant IEC-BCC materials (leaflets, brochures, posters, stickers, etc.) were also distributed among the people and gummed in the visible public places.

Under the support of USAID's Justice for All program, Pabna, Light House and District Legal Aid Office have organized a coordination meeting with the Panel Lawyers and Judges in May 2017 where 44 participated. Honorable District & Session Judge, Mr. Nuruzzaman chaired meeting and his speech added with the legal aid services of Bangladesh Government and how it can be improved further for the helpless. He spoke about the challenges of panel lawyers what they are facing now and besides he also expressed his satisfaction on the support of USAID through Light House which improved case referral and DLAC's capacity.
