



Observance of International Day against Drug Abuse and Illicit Trafficking

Supported each year by individuals, communities and various organizations all over the world, the 26th June as International Day against Drug Abuse and Illicit Trafficking observes based on the resolution 42/112 of 7 December 1987 of General Assembly aiming to raise awareness of the major problem that illicit drugs represent to society. Bangladesh is not the exception of this, each year under the guidance of Department of Narcotic Control of Bangladesh Government along with the GO/NGOs observes the day.





However; in 2017, due to the Eid-ul-Fitar, the days was observed countrywide on July 26, instead of June 26. Light House and its relevant projects observed the day at central and local level in collaboration with the Department of Narcotic Control. "Listen First: Listening to children and youth is the first step to help them grow health and safe" was the main theme of this year. Light House and its project participated and supported the program organized by Department of Narcotic Control at central and district level. The observance activities includes; Human Chain, Rally and Seminar, Essay and Drawing Competition and prize distribution Ceremony, etc.

USAID's team visited JFA -Pabna Project

USAID's JFA team visited Pabna Program on July 26, 2017 and met the Honorable District & Session Judge as well as District Legal Aid Officer. The team tried to collect the ways to improve the legal aid program of Government during discussion. USAID's team visited JFA -Pabna Project

Light House managed HIV prevention project for female sex workers introduced analysis on recorded temperature of the medical products knowing that heat affects many of the products, it melts ointments and creams and causes other products to become useless. As the temperature in Bangladesh was remained so high due to summer which encouraged project team to critically monitor the recorded temperature of all Drop-In-Centers in June 2017 and later the analysis put under a continuous process. In July 2017, the project measured the temperature outside the cupboard only for the day and found the recorded highest temperature beyond the range in 21 Drop-In-Centers (Below Table states the details). Shifting of medicine cupboards comparatively in cooler space temporarily really helped in keeping the temperature of medicine cupboard within the range of 28-30 degree Celsius.
